VERY SAD NEWS

I am saddened report the passing of long time Triton, Glenn Beall on Thursday, July 24, 2025. Glenn was 91 and had moved from his home in Libertyville to a retirement community in Lake Forest. His office went with him. Glenn was a globally recognized innovator in the plastics industry. He obtained 35 patents over the course of his career. He was an author, educator, editor, expert witness and industry activist. He was inducted into the Plastics Hall of Fame in 1997. In 2022 Glenn was the first American to be inducted as a Liveryman of the United Kingdom Worshipful Company of Horners, an organization founded in 1248. There will be a Celebration of His Life in September, date and time will be announced.
